The construction works is expected to be completed within 12 months from 22 January 2024.

Kerjaya chief executive officer and executive director Tee Eng Tiong said, "We are both ecstatic and honoured to be continuously selected and trusted with projects from our long-term established clients of which Kerjaya has formed a firm bond with. We are only into the first few days of the new year yet, together with the RM170.9 million contract which we received last week, Kerjaya has already secured a cumulative year to date contract value of RM266.1 million. We undoubtedly intend to continue expanding our order book to meet our internal target of RM1.2 billion for 2024."

He further added, "Kerjaya will maintain its direction to position itself as a resilient construction player in Malaysia and will continue to seek out projects that are not only lucrative in returns to our shareholders but also provide opportunities for us as a renowned high rise construction player to develop and enhance our engineering skills and offerings."
