Bhd. ("the Client") for the construction of two blocks of office suites ("the Project").

The Project is located on Lot 240, 900 & 1137, Jalan Sunway Semenyih, Mukim Semenyih, Daerah Ulu Langat, Selangor which covers:

- 2 blocks of office suites of 40 storey Block A and 34 storey Block B,
- 8 levels of Podium,
- 13 units of double storey shops,
- 1 recreational center, and
